ABSTRACT

This project was focused at designing and implementing an android cropguard and pest control application system which will assist farmers to acquire farming knowledge and know how they can deal with pests and diseases so as to improve the output. Experts in farming will be able to offer expert advice to farmers and as well acquire additional knowledge and try new crops. Farmers would be able to report their needs to the ministry of agriculture and make the ministry of agriculture recognize farmers in different regions. Ministry of Agriculture Information Technology will be able to assign roles to the experts and extension officers and create a knowledge base which will be useful in the future. Experts remains in their line of expertise thereby could not try different crops. They remain with limited information but through the use of the proposed system they will be able to increase their knowledge. Administrators spends a lot of time in offices but due to the use of the system they will be able to try farming during weekends and public holidays which intern benefit them and their families. Farmers has no knowledge of where exactly they ca access farming products and their prices. Farm shops has no knowledge of which products should always be available in storage

CHAPTER ONE: INTRODUCTION

1.1 Introduction

This chapter outlines the research problem and all aspects related to it. Issues covered include the background of the study on this project and then look at the problem definition which briefly explains what farmers are experiencing. The objectives of the study are stated giving full detail on what is intended to be done. It further gives the significance of the study to the farmers in Zimbabwe and gives the delimitation which outlines the beginning and the ending of the research and limitations of the study which are constraints which could prevent the study from being completed.

1.2 Background of study

According to Jorgensen (2016) farming started long back ago when people would cultivate what only was enough for them and if they had excess they would exchange with what they wanted known as trade exchange. Crops cultivated included maize, beans, vegetables, fruits only to mention but a few. Animal rearing was also practiced as part of farming and the animals included goats, cattle, sheep's, chickens, donkeys and animal skins was used as clothes and seating mates among other uses. But still crops failed due to poor soils and pests affecting crops and animals.

Places in Manicaland and Matabeleland, many farm produces are failing because of poor soils and pest and diseases infections and the system is a solution to all the crop failure due to a number of reasons some which includes poor soil management and poor crop management only to mention but a few. Farmers are harvesting below the best grade farm produce when they can maximize the output using whatever the space they have. The system is for both small scale farmers as well as large scale farmers and commercial farmers of cause.

1.2.1 Background of the organization

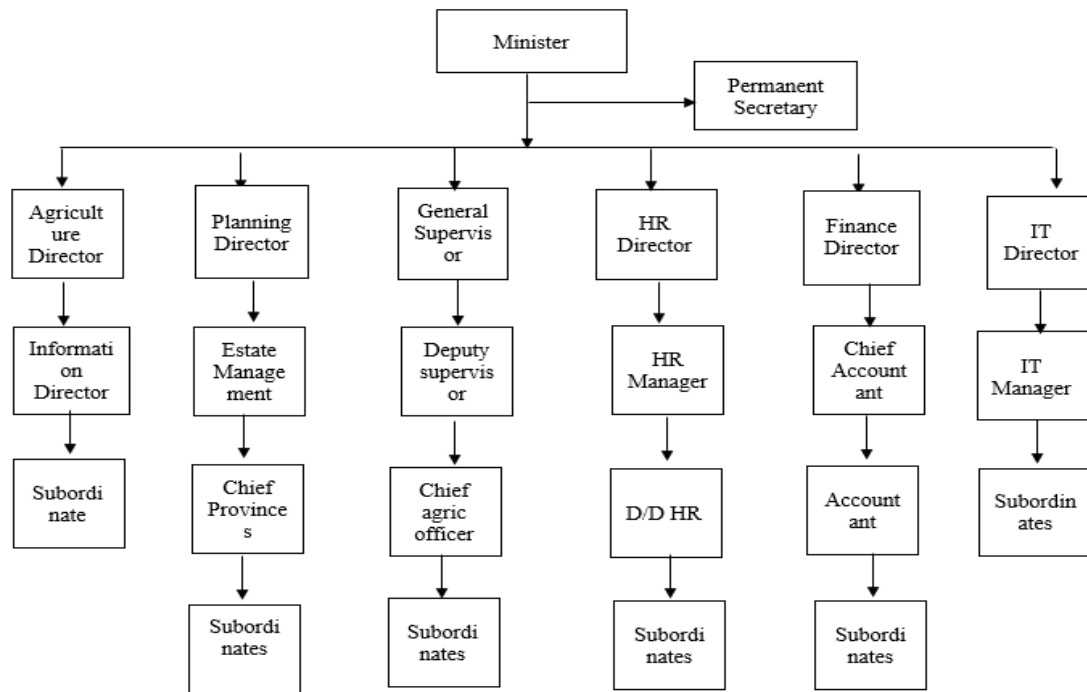


Figure 1.1 Organogram

1.3 Problem definition

- Few farmers are not known and their needs are not heard and catered for which result in them not having enough inputs and enough knowledge about farming different crops which is lessening the crop production and thereby reducing the nation's GDP
- Farmers have little knowledge on how they can cultivate their crops which is leading to a lot of declining in soil nutrients and raising soil PH will lower down the final produce and due to poor produce potential farmers are not eager to try farming as they see think there will be no return.
- Pests and disease infections normally spreads throughout the farm and destroying a lot of crops as a result that they are not taken care of during the early stage thereby having a greater impact.
- Farmers have limited knowledge on where they can find pesticides and insecticides and how much do they cost which is causing poor budgeting in a way that they will not be

able to buy them in the middle of the farming season thus affecting the final produce as the crops will be greatly affected by not having the pesticides.

- Farm animals are dying because farmers do not know the possible disease affecting the animals and how they can prevent them or if affected they have little knowledge of the chemicals used for the disease and where they can access it with the price and dosages.
- Experts have nowhere to display their knowledge

1.6 Instruments and methods

1.6.1 Instruments

The project was implemented using the following:-

- **Programming Language-** Android IDE which is used to develop system that run on android operating systems such as phones.
- **Database-** MySQL- is a fast and robust multi-threaded SQL database server with a client/server implementation which helps to store data for future use and future reference and to see areas that upgrades to the system should be done.

Farming is the backbone of the country as most of our products comes from farming and we export to supplement that which we need the most, the system will provide solutions on poor soils and pest and insects which are damaging crops and animals thus lowering the output. The system consists of expert farmers giving advice and providing solutions to questions asked. The system can be accessed on android mobile phone that make it accessible by many users.

CHAPTER TWO: PLANNING PHASE

1.9 2.1 Introduction

Information about where to access pesticides is provided as well as price quotations which will help farmers budget for what they might need throughout the farming season. Extension officers will be able to know more and know the experts in farming. Knowledge of where to access farming products and their prices will be available.

The ministry of agriculture will be able to recognize each and every farmer in different regions and know their needs. It helps the ministry help farmers so as to miximise farming production.

Farm shops will be able to showcase their available products and prices. They will be able to have the knowledge of which product to keep in store and their price comparing to competitors

They can make use of the system for personal benefits and try farming which is good for the families. As an author having access to all the information being provided I would like to give farming a try.

1.17 2.3 Feasibility study

Kendal (2016) states that feasibility study guides the organization in determining on whether or not to proceed with a project and identification of the important risks associated with the project that must be addressed given that the project was approved. It can be a measure of how practical or beneficial the proposed system would benefit farmers. It helped in the analyzation of possible alternative solutions to farm related problems and a recommendation on the best measures to take. It justified the development of the proposed system and outlines why the project should be discontinued. The chapter assisted the author to determine whether it was possible to develop the system in-house under the prevailing economic, financial, organisational and technological constraints and whether the costs of the system compared with the benefits and if benefits outweigh costs the system will be feasible.

1.18 2.3.1 Technical Feasibility

Technical feasibility is resources needed to develop the system. This is the identification of system requirements which includes inputs, software facility and procedures. User friendliness and greater processing speed are offered by the system. Maintenance costs are very low as farmers only requires an android cellphone to run the application and the farmer is notified if there are any upgrades. Considering the technical facilities needed to develop the system it will be successfully executed as the facilities are available.

2.3.1.1 Technical Expertise

Kendal (2016) says it is an assessment measure to see if the system can be built or not and the availability of technical expertise. This was established to assess whether expert programmers capable of developing the system before it was developed and in this case the ministry has enough developers within the organization who were well vested in different programming languages. The developer could consult other software developing companies or individuals if they needed any more clarifications about the system.

1.19 2.3.2 Economic Feasibility

Most commonly referred to as cost/benefit analysis to determine the advantages and savings expected from a system and comparing them with costs and make decisions on designing and implementing the system. It gives enough economic justification for the new system. The developer doesn't need additional hardware resources and it should be saving a lot of time.

A system is feasible when benefits outweighs costs of developing the system.

2.3.2.1 Costs

2.3.2.2 Development and maintenance costs

These are costs incurred in the development stage of the cropguard and pest control system for instance software and user training Hullet (2016), The farmers and the developer are going to incur these costs and maintenance costs in the life cycle of the system. 2.3.2.6 Comments to the Cost–Benefit Analysis results

From the obtained results the benefits are greater than the costs and the project can safely continue. Timing and costs are taken into account and benefits relating to the investment size so as to choose between projects. Return of Investment (ROI) method is used to compare projects basing on their cash flows

2.3.2.7 Return on capital employed, (ROCE)

Measures the return per each dollar of capital invested in the business and is expressed in percentage in this case will calculate it for 3 years.

The return of Investment is a simple, easy to calculate measure. In this case a percentage of initially the project has a higher return which means the ministry will benefit from the proposed system and probably the returns will continue rising as the project progresses hence the project can be carried on as the ROI figure is very high.

2.3.2.8 Net Present Value

It is the most appropriate and recommended investment appraisal technique which assists in determining if the project is worth taking or not. The project is accepted if the NPV is positive as it has greater benefits vice versa. It is recommended over other investment appraisal techniques as it considers time value of money, uses cash flows instead of accounting profits which can be manipulated and it factors in risk through discounting cash flows into present values.

1.39 2.3.3 Social Feasibility

Kampira (2018) says this is how the users will interact with the system. Socially cropguard and pest control system has been accepted as it was designed to make farmers to have a better control on their farm produces. It shows the impact of the proposed system to the farmers. The system will encourage more produce thus improving Gross Domestic Product (GDP) which will benefit every citizen.

1.40 2.3.4 Operational Feasibility

Operational feasibility focuses on identifying problems within an existing system. Will make use of P.I.E.C.E.S framework:

Performance problems- The current system is very much unreliable as the farmers ask around for advice and be told what one think works which may not be the best. When using the internet, a lot of conflict information is provided thereby one getting confused about the best idea to take.

Information problems- Conflicting and biased information can be accessed from the internet and get biased information from fellow farmers.

Economic problems- Due to the economic hardships the country is currently experiencing it is very rare for one to buy bundles to go on the internet but rather ask around and getting biased information which at the end affects production

Control problems- Control for the current system is a hard nut to crack as the internet cannot be controlled by anyone and farmers cannot control what they are being told but can do so by assessing the provided information.

Efficiency problems- The current system is not even efficient as the internet maybe affected by poor network. Asking from fellow farmers proved hard as they may be unavailable or end up talking staff unrelated to farming.

Taking into consideration of the above explained problems the developer used the problems to come up with the system that can do away with all the stated problems of the current.

1.41 2.4 Risk Analysis

During system development a number of risks will be incurred. Risk analysis points out the key risks associated with the project Dennis et al (2015).

1.43 Management

Management will have overall control of the system through budgeting of resources allocated to the project which include money and time. Management support will encourage other stakeholders to view the project in a positive way.

Users

Some farmers are illiterate in such a way that they will fail to use the system. Other farmers might welcome this project as they will be able to acquire expert advice and know better about farming. The farmers highly support the project thereby the risk being low.

The system will meet the set obligations when it comes to receiving advice considering that the farmers did not have such a system to use. System maintenance and upgrade will be a problem that farmers might be faced with. A full backup of the system will be required such that a knowledge base will be generated. Design problems were encountered as there was not enough time to perfectly look at the project. The technical risks are not important as there is another plan if system failure arises.

The proposed system has been socially approved as it will help farmers to acquire expert advice from experts and extension officers. The system is quite easy and interesting to use.

The ministry has to well budget for the project so as to avoid shortfalls. All the resources were available and on time. CHAPTER THREE: ANALYSIS PHASE

1.0 3.1 Introduction

The chapter focuses on gathering information so as to get a clear understanding of the existing system and current systems dataflow diagrams and context diagrams so as to get a better understanding of the importance, complexity and scope of the existing challenges.

1.2 3.2 Information Gathering Methodologies

This stage helps in acquiring detailed knowledge about the system from all associated users.

Methods used include:

- Questionnaires
- Interviews
- Observations
- Document review

Using the above methods gathering data but they have their strength and weaknesses. By overlooking them it helped eliminate the problems associated with others. It helps give light to the project carried out. Provide the analysed problems associated with the current system so as to come up with the best solutions.

1.3 3.2.1 Interviews

According to Kendall (2016) interview is a technique of gathering information face to face from interviewees and the types includes structured, semi-structured and unstructured. The analyst will select which one between the three is the best to use.

3.2.1.1 Structured Interviews

Each and every question outlined must be read thoroughly by the researcher without saying or meaning otherwise. Should be able to take note of body language, facial expressions, and emotional affect. This is the most used interview type. It is most useful when looking for very specific information. Keeps the data short and precise.

3.2.1.2 Semi-structured Interviews

Much more flexible. Small room for clarifications and additional information. There is freedom of being friendly. Used when the information is much personal. Participants' trust can be gained and better response understanding. Larger data sets are obtained.

3.2.1.3 Unstructured Interviews

They are much more flexible. The interview was more like a conversation and the researcher only had a checklist of topics. So much information can be uncovered in response to the researcher's topic. There was no limitation to the protocol as the researcher and the respondents were free to air out their responses. Management, farmers, extension officers and experts were selected for the interview. As an analyst, unstructured interview proved to be more beneficial as compared to the other types.

Unstructured interview was the most preferred technique as it:

- Allow for direct communication with the people responsible of the current system thus, the analyst got a first-hand understanding of how farmers access their farming knowledge as well as the problems they are facing and what exactly do they expect from the system.
- The interview offers immediate responses.
- It was very private and confidential.

3.2.1.4 Advantages

- Immediate and direct responses were obtained
- Participants were free and requested for questions, interpretations or elaborations which encouraged truthful answers.
- What is currently happening was clearly layered out.
- There was room for additional information and clarification.

3.2.1.5 Disadvantages

- The method took a lot of time to conduct.
- Respondents were busy working in their fields and answered to get over with the interview as the interview took place during working hours.
- Some interviewees gave biased answers as they could not understand the demands of the questions.

3.2.1.5 Findings from the interviews

The author discovered farmers have little knowledge about farming activities and they have little information source to rely on which is a challenge for them to maximise output and try new crops. Experts are there but they are not recognised and have few farmers to share their expert advice with. Farmers needs are not heard and taken care of especially by the ministry of agriculture.

1.5 3.2.2 Questionnaires

According to Kendall Kendall et al (2016), is a data collection method which allows analysts to study attitudes, beliefs, characteristics and behavior of those affected by the current and the proposed system. Questionnaires were issued to most of the farmers farming different crops. They were designed and distributed to the farmers asking about the challenges associated with the current system They are less costly and responses maybe be compared from one farmer to the other. They ensure anonymity thus respondents are free to air their views. They are more objective however respondents may forget important issues as the method occur after event. The author used open ended and structured questionnaires

3.2.2.1 Open ended questionnaire

Open ended questionnaire allows respondents to answer whatever they feel. Large amounts of data are generated which takes time to process and analyse. Respondents may provide unclear answers especially if the questionnaire take long time to complete

3.2.2.2 Structured questionnaire

Responses are straight to the answer as respondents can only answer with a YES or NO and there is no full expressing of oneself and will save on time.

3.2.2.3 Advantages

- More information can be gathered
- They feel free to air out their views

3.2.2.4 Disadvantages

- Provides unclear answers

- Some questions are left unattended as respondents could not understand them
- Takes a lot of time to gather and compile the information

3.2.2.5 Findings from the questionnaires

It was discovered that some respondents could not understand the demands of the questions due to the inability to read and write properly. It took a long time to gather all the information and some answers were hard to interpret and draw meanings from. Some questionnaires were never returned which made it more difficult to draw a good conclusion.

3.2.2.6 Response rate

As it is well known that people doing farming do not worry much about being able to read or write which greatly affected the responses gathered. About 50% of responses were returned and some were spoiled or the answers were unclear.

3.2.2.7 Target population

- The researcher was mainly targeting young commercial and small scale farmers with the idea that they were able to provide best answers. Farmers who had many years doing farming were targeted as they knew better and knew ways that could be done so as to increase farming in Zimbabwe.

1.6 3.2.3 Observations

According to Otto (2013) this type of technique is basically developed to observe people in doing their day to day activities. The observer can participate or watch people doing what they do and have the know-how of the current system. With this technique the observer was able to see what they may require to make farming easier and to observe if they are farming properly and how they treat pests and diseases.

3.2.3.1 Advantages

- It was less costly as no material was required
- Data relevant to the context was obtained.
- First-hand information was obtained.

- No bias
- Identified unanticipated outcomes

3.2.3.2 Disadvantages

- Most farmers changed their behaviors as they felt that they were being watched which led the observer not to get the exact information that was needed leading to biased conclusions.
- Few operations were observed.
- Proved to be expensive and time consuming
- Could not observe and analyse the respondent body language.

3.2.3.3 Findings from observation

Most farmers had little knowledge about farming though they had many years doing farming. They did not know where to access farming products and the best product to use. They had a lot of needs which ministry of agriculture should take care.

1.7 3.2.4 Documentation review

Otto (2013) states that document review is looking at the previous used documents so as to get an insight of the current system. To get an insight of the current system the researcher had to look at the farmer's documents through the management. It was easier to understand how the current system works.

3.2.4.1 Advantages

First-hand information was obtained

3.2.4.2 Disadvantages

Incomplete information as reports could not explain data source.

3.2.4.3 Findings from documentation review

Not much was found from document review as farmers did not document most of their activities

- Need little technical knowledge so as to use the flow chart as communication between users and analysts.

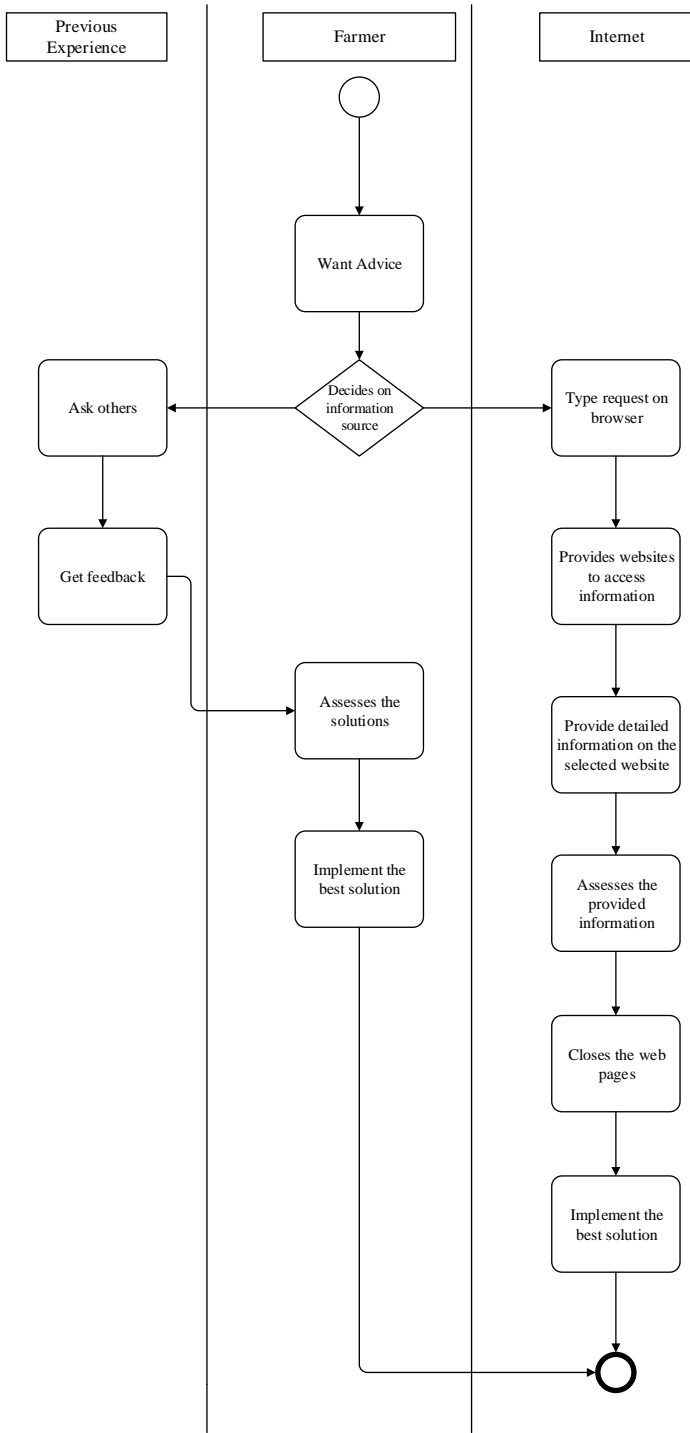


Fig 3.1 Activity diagram of the current 28

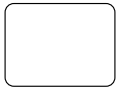

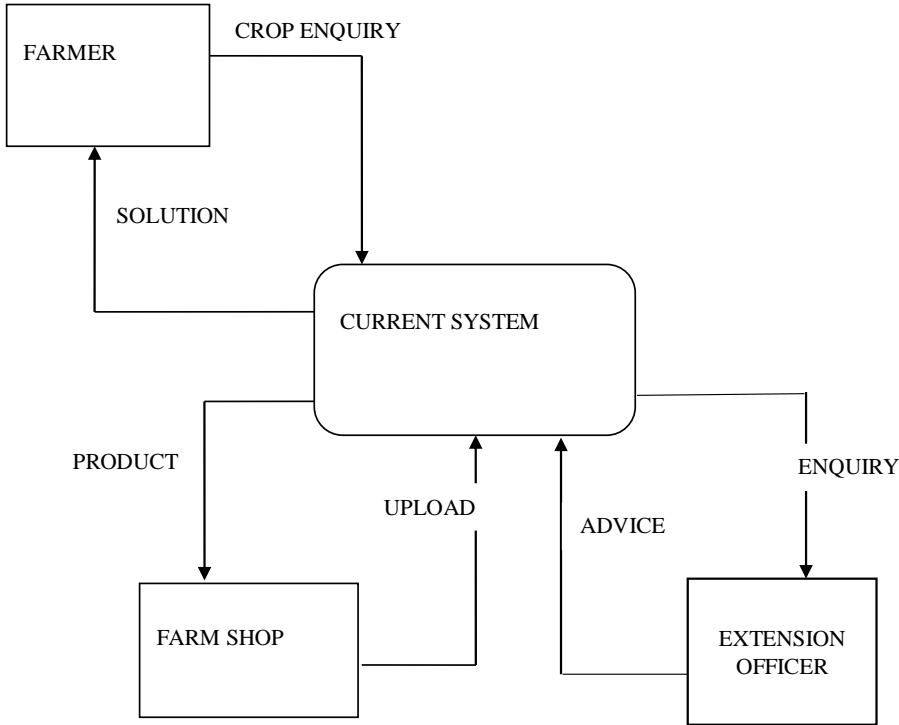
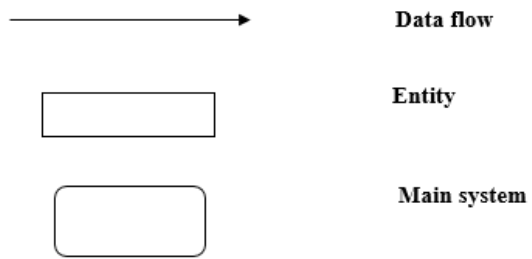


Fig 3.2 Context diagram of the current system

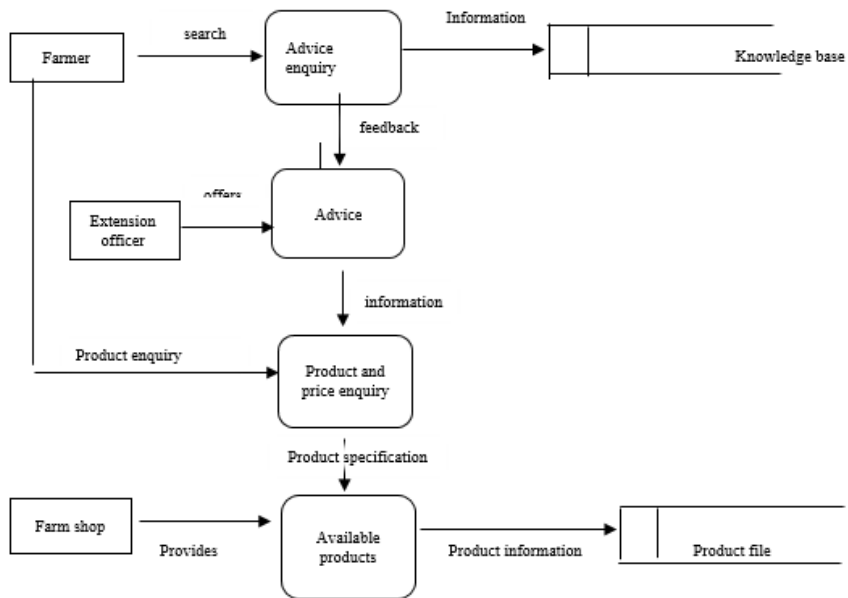


Fig 3.3 dataflow diagram of the current system

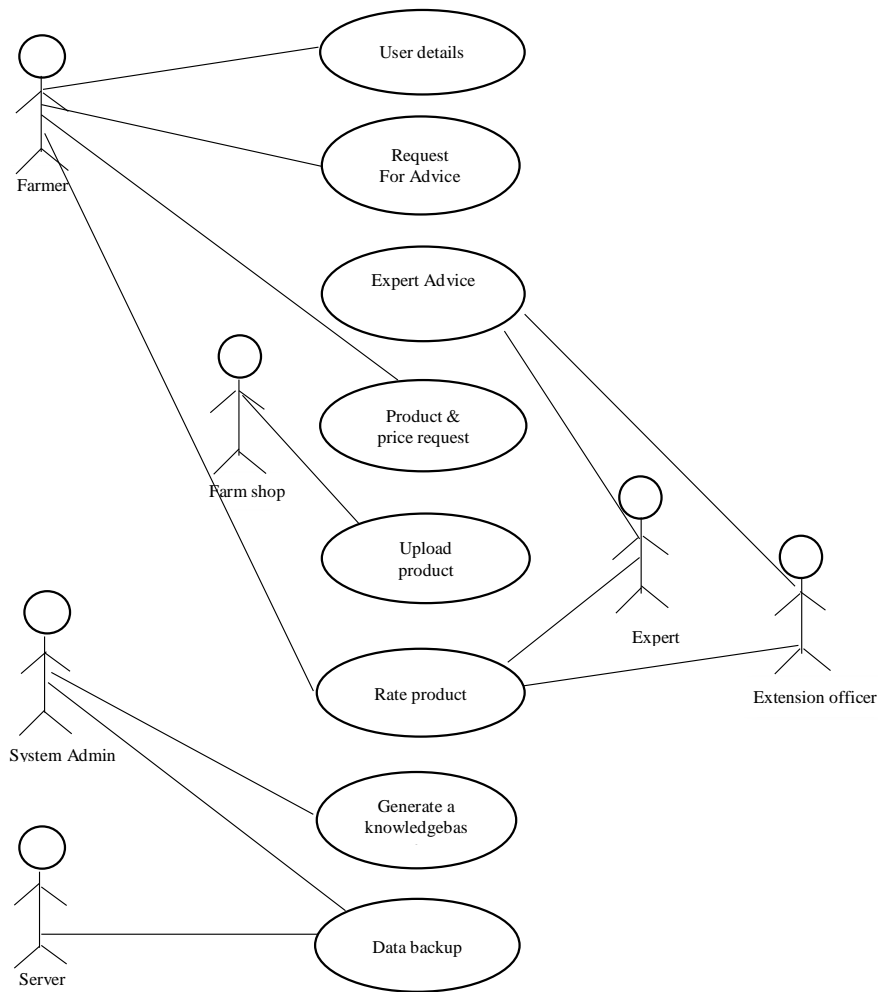
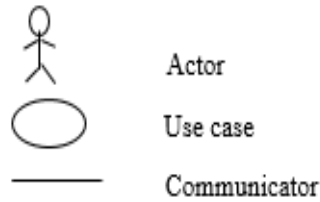


Fig 3.4 Use Case diagram

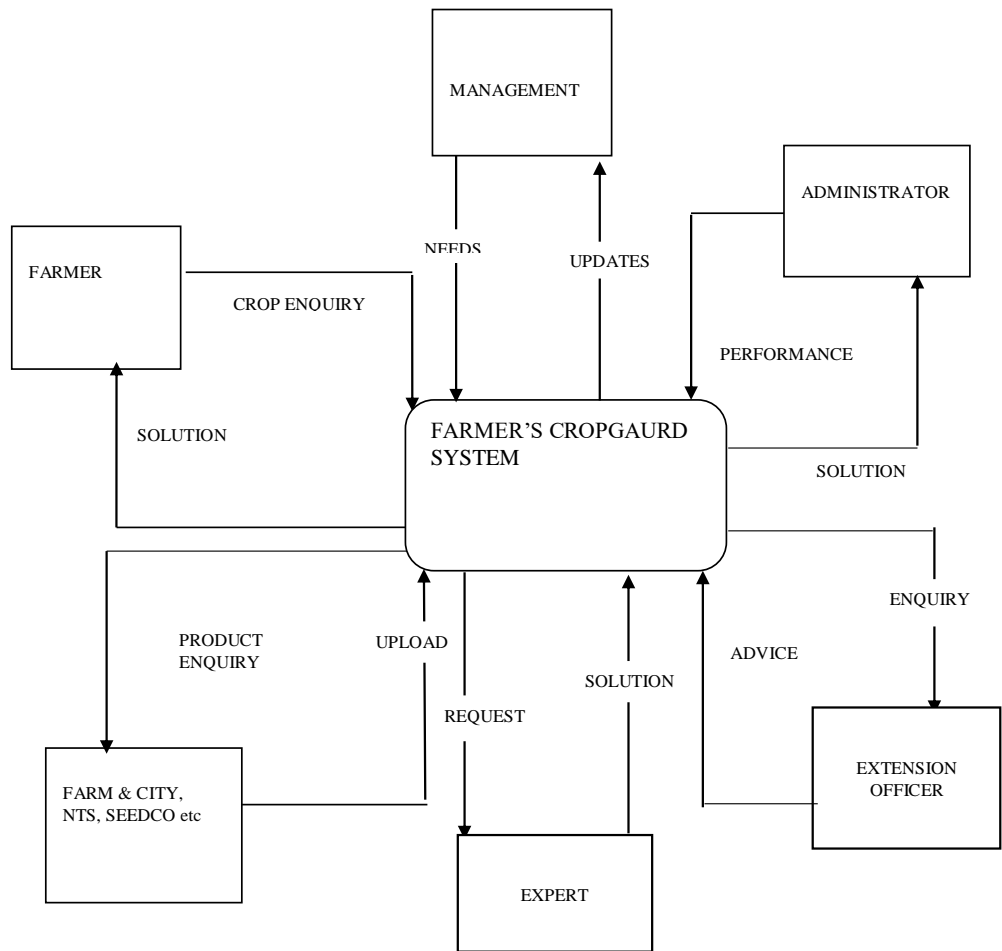
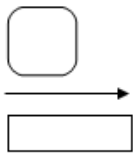


Fig 4.1 Context diagram of proposed system

Data flow diagram for the proposed system

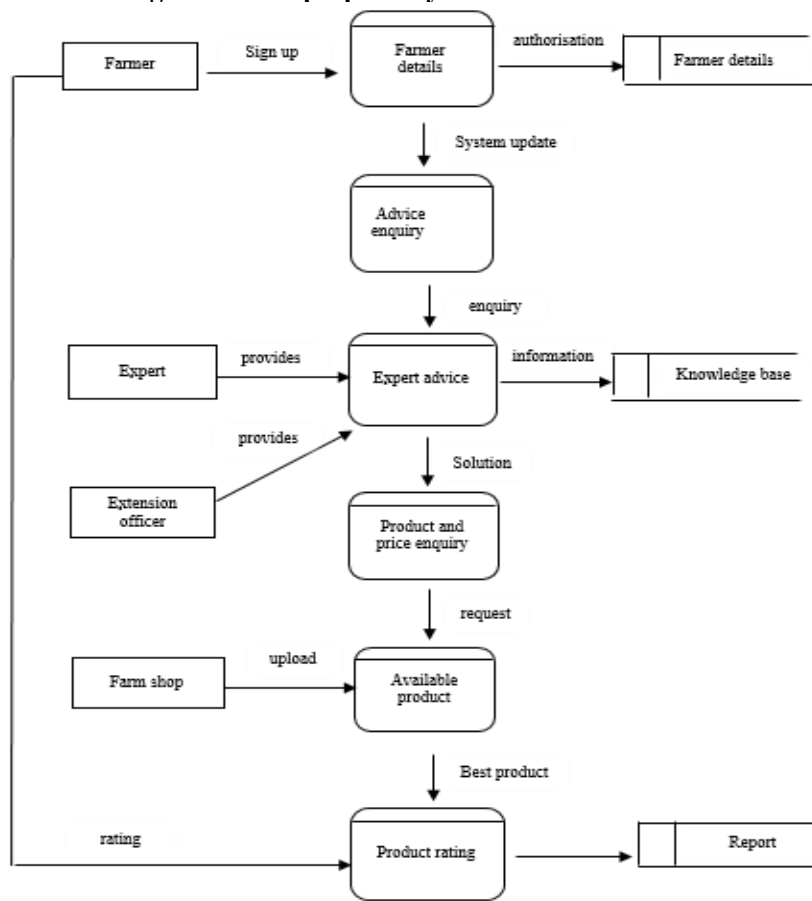
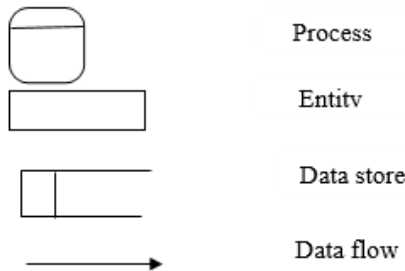


Fig 4.2 Data Flow Diagram of the proposed system

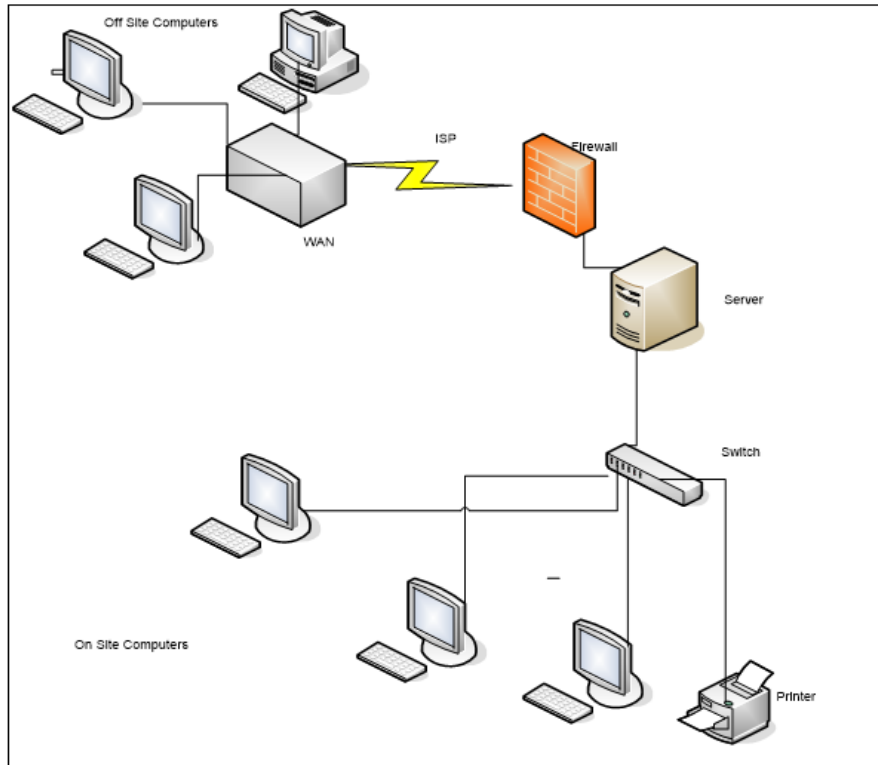


Fig 4.3 Architectural design of proposed system (Z M..... et al (2017)/

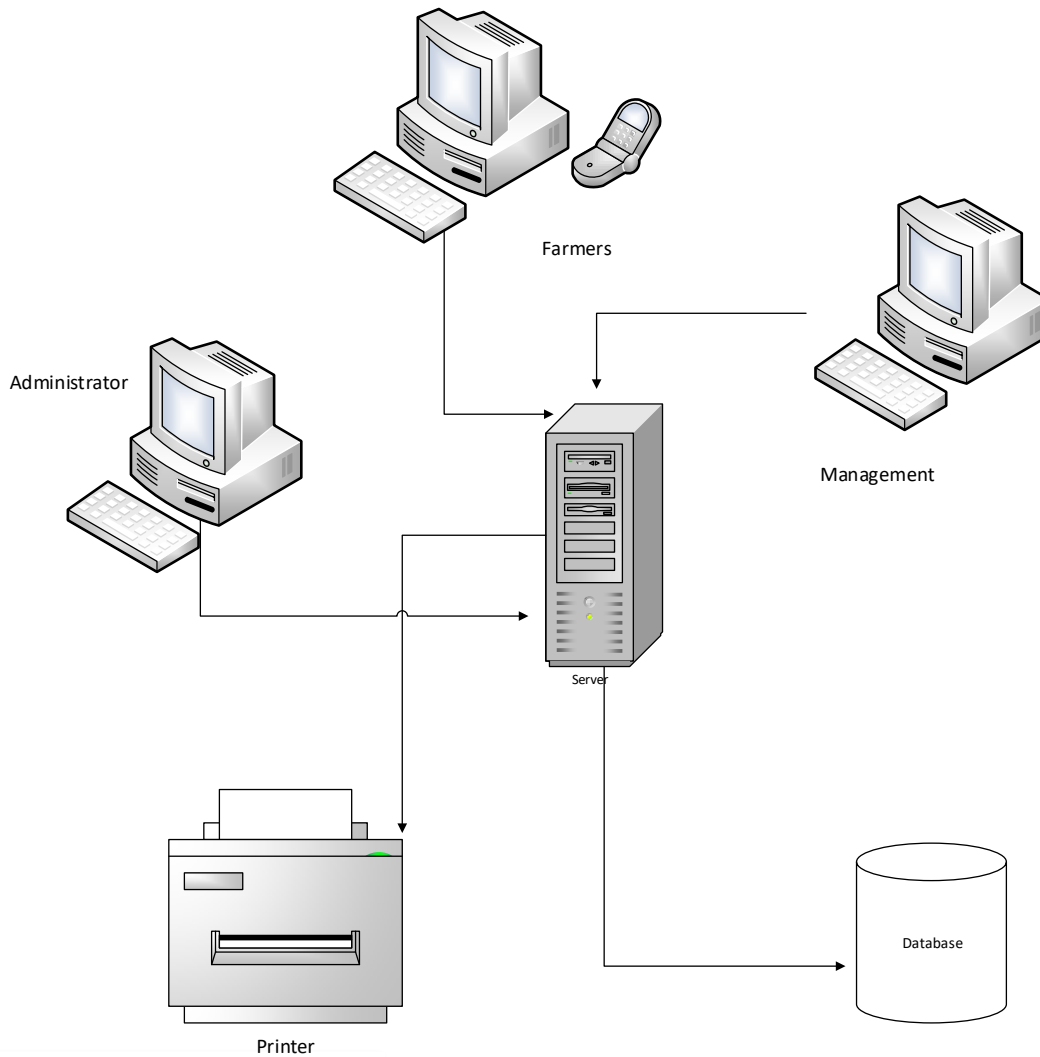


Fig 4.4 Physical design

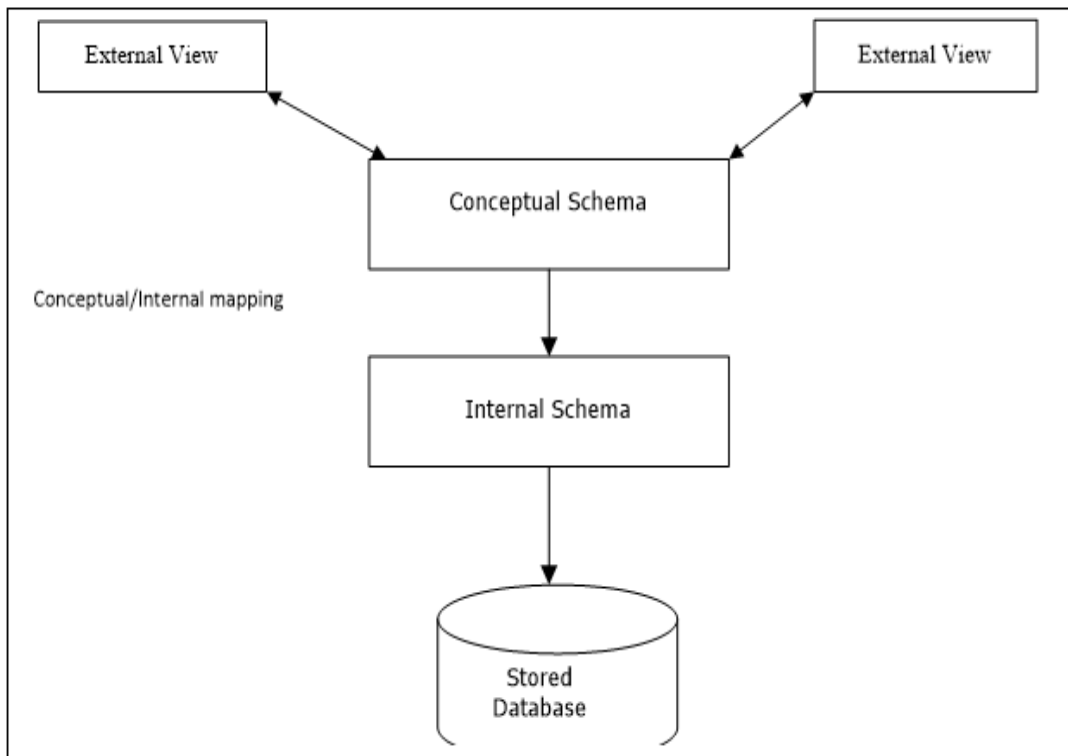


Fig 4.5 Database design

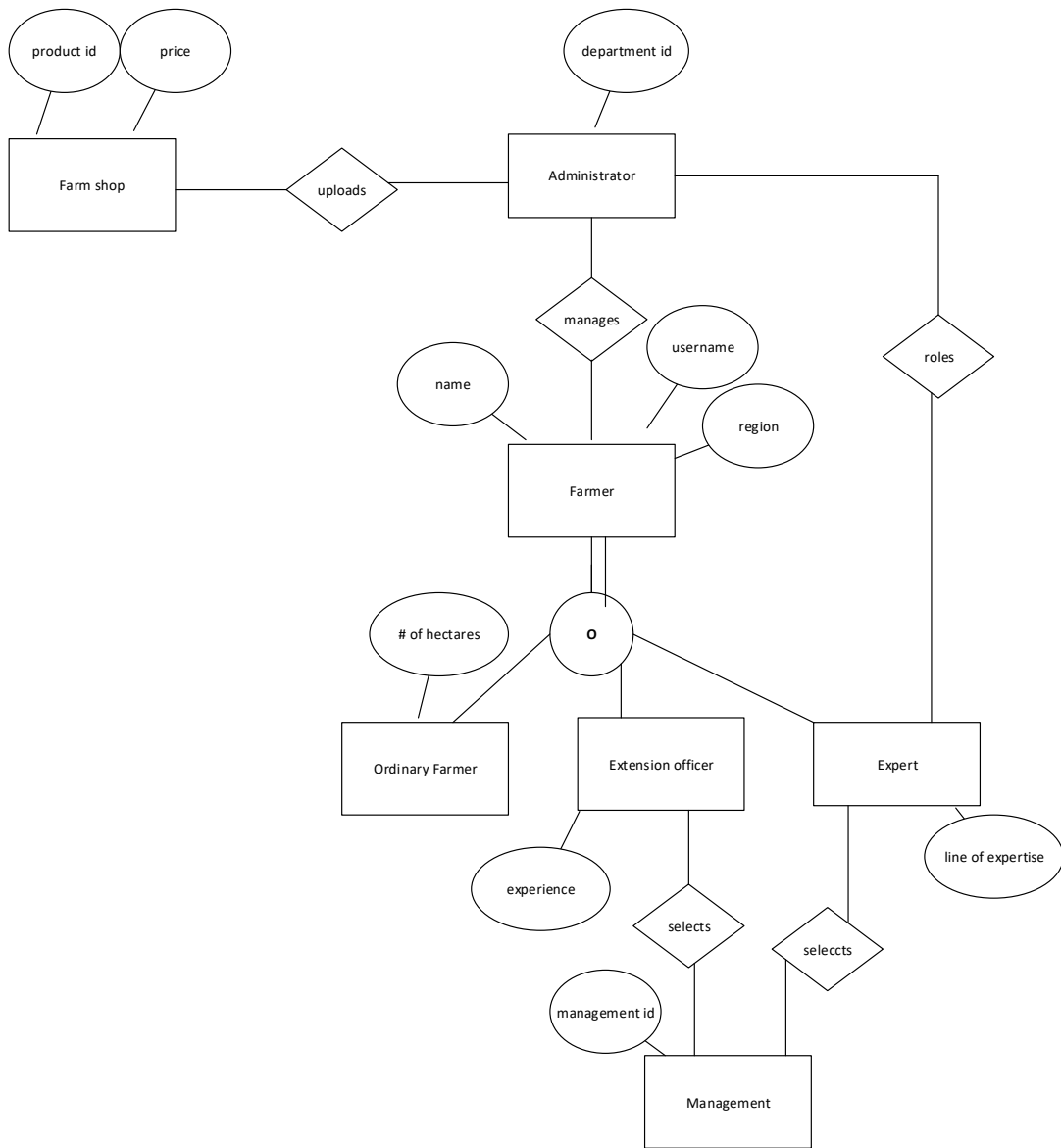

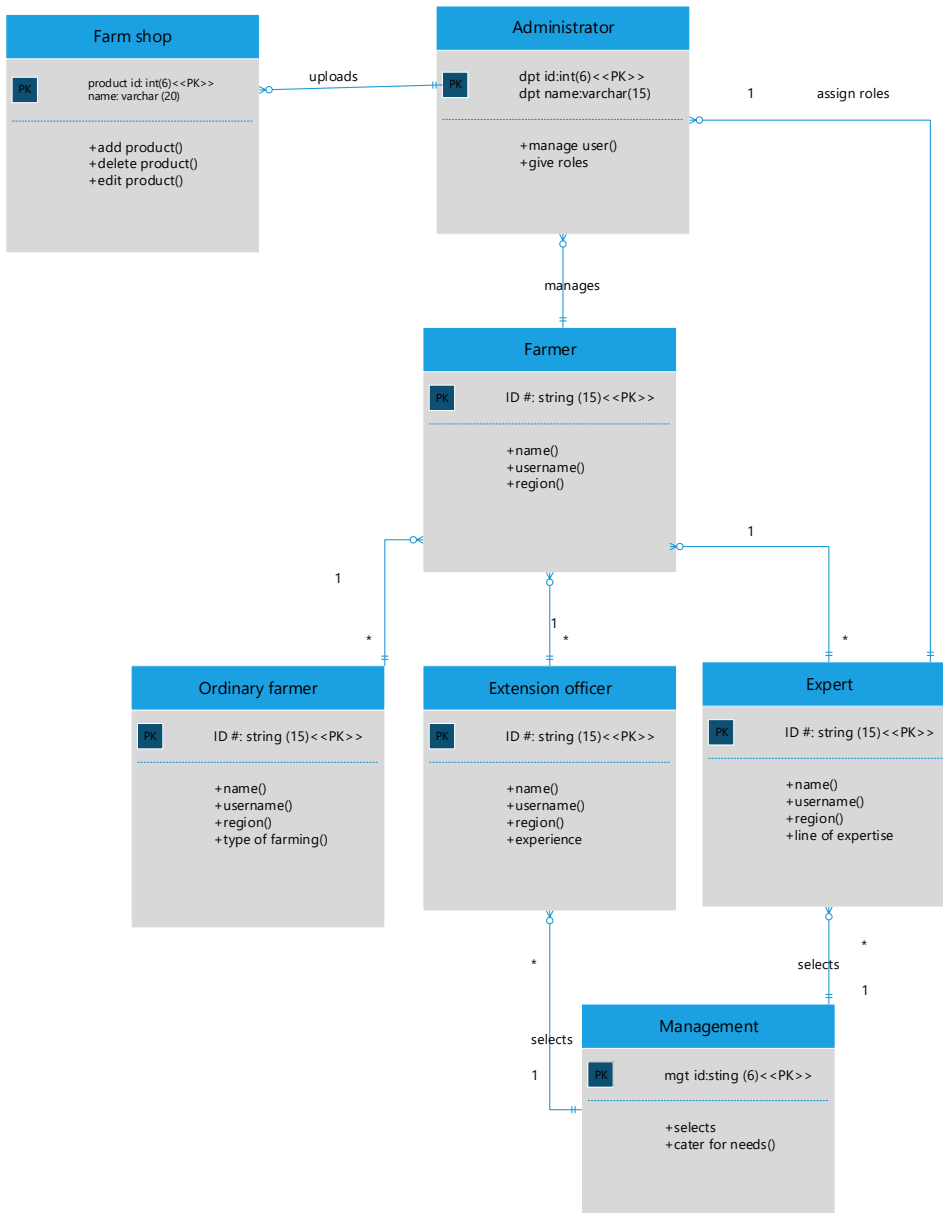


Fig 4.7 cropguard and pest control System Class Diagram

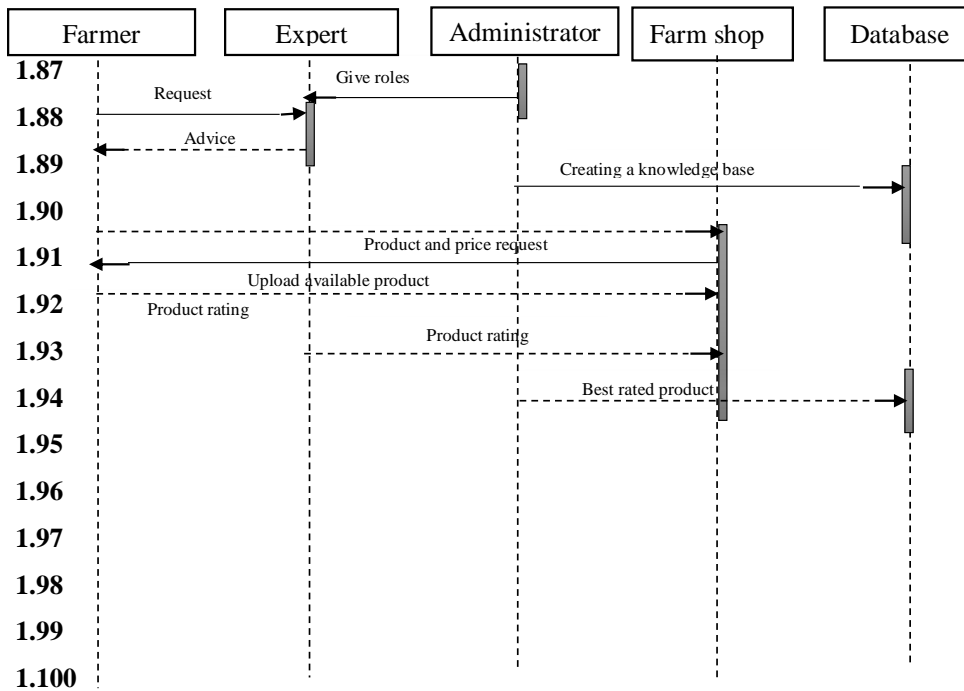


Fig 4.9 Sequence diagram of proposed system

The security design focuses on how the system prevents from any threat Shostack (2014).

Threats come from various ways which can be from the hackers or from natural disasters such as

flooding and the system was designed in such a way that risks will be minimised and good infrastructure for the system be built. The following are the security concerns:

4.9.1 Software concern

Limits user access with the use of login control and can only access what they have been assigned by the administrator and those only with the right can access the system. Unauthorised users must not access the system as it will pose many threats such as information loss as that user format all the data.

Access levels

Access levels include system access, module access and menu access. The system should only be accessed by the administrators who has administrator log in credentials so as to keep the information private and confidential. The farmers should only access their application using the menu available and be able to perform what only they should and the rest is done by the administrators.

Physical concerns

The following levels of physical security concerns were taken note of the users can access the system using their credentials. CCTV's should be installed in the server room so as to monitor people who gets in and out of the server room in case something happens. The machines used should be quite high above the ground such that there will be no contact with fire. The rooms should have fire extinguishers in case there will be a fire. Information should be backed up regularly so as to prevent information loss.

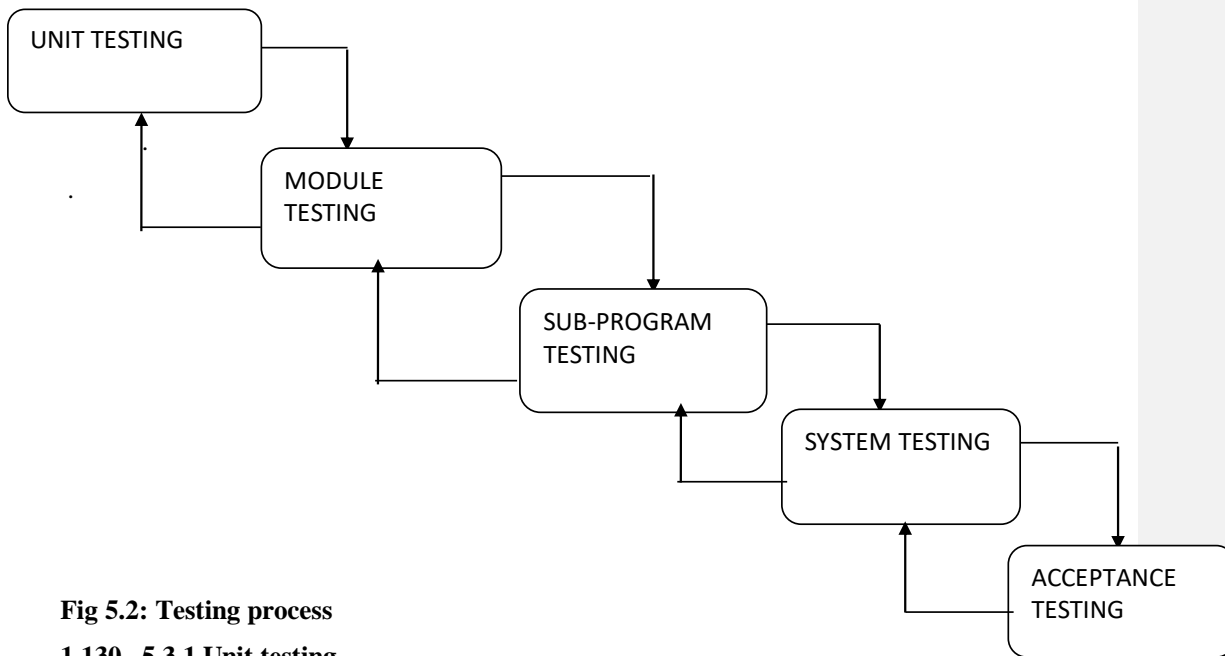


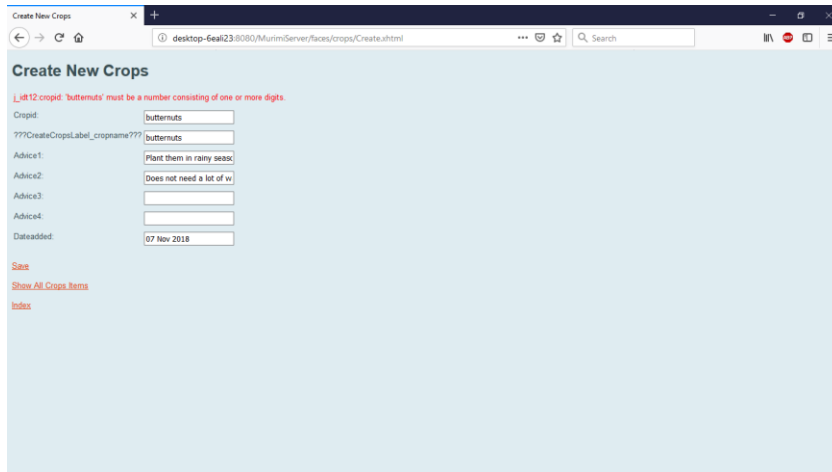
Fig 5.2: Testing process

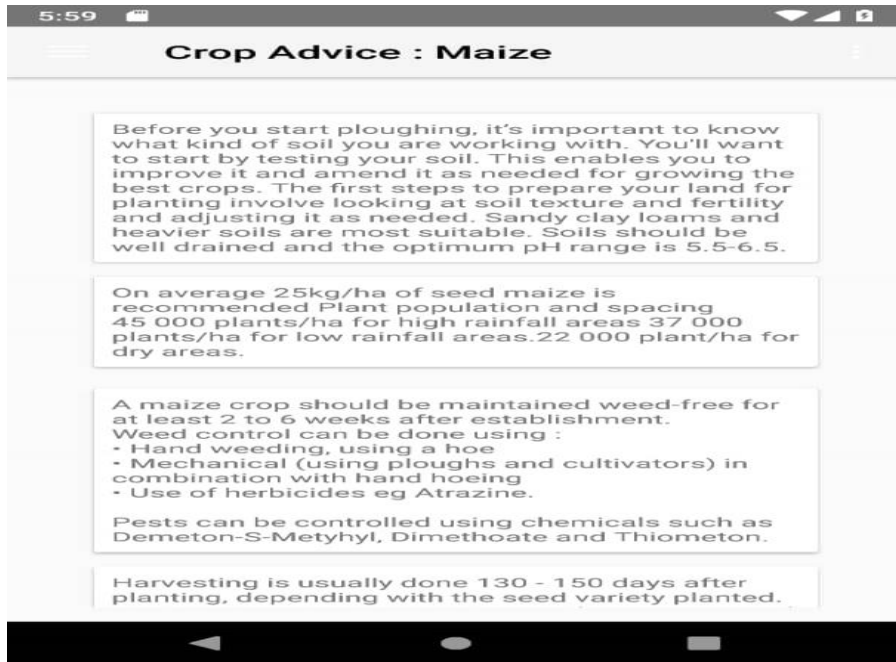

Related system modules formed subsystems which were tested for data, stress, and error integrity. Database as a subsystem was tested independently. Related subsystems were tested for data stress and error integrity. Database was tested independently. The purpose of subsystem testing is to test the interfaces between programs in the same functional area. Each program is linked to all the other programs with which it interacts. What is being tested is not only that the data is correct and in the correct format, but that it happens in the specified sequence and within the specified response time. 1.138 5.3.4 System testing

Debbabi et al (2014) state that system testing involves testing of the entire information system and it includes all processing situations. This involves testing of all subsystems as one system so as to find if there were any errors which affect system performance. Made use of live data and verification to see if the whole system worked as intended. The developers validated the completely integrated system by testing end-to-end capabilities as in test plan. Produced a user manual produced a system documentation. It will be complete when all the specified tests in the system plan has been run successfully. The following diagram illustrates system testing as the administrator can view all the processes taking place in the system:

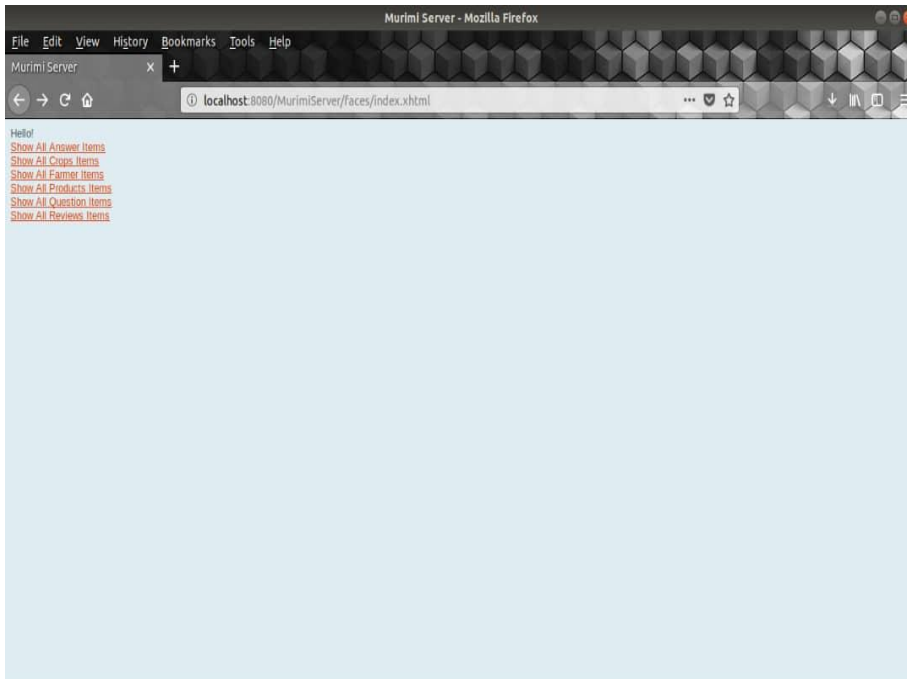


Fig 5.7 System testing

1.139 5.3.5 Acceptance testing

This is the stage before system acceptance by ministry of agriculture (Sommerville, 2004). The system was tested with data supplied by the farmers and experts in farming as well as farm shops. Users were called in such that they point out where there were errors and omissions such that they would be perfected and gave comments on whether they accept the system or not and whether the system performed as intended by the farmers until the system performed as intended by the farmers.

and does a lot more than what it is requested of it. The system should allow for developers to see the final product

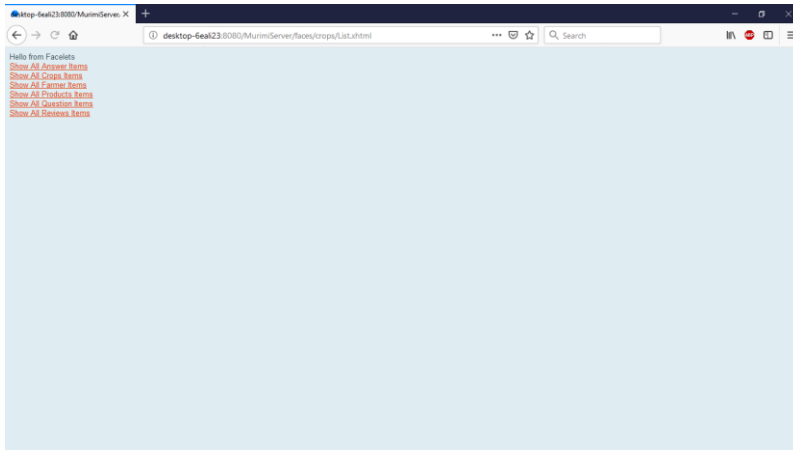


Fig 5. 8 Verification

The system is tested using real data supplied by the farmers and the administrators and the management who will be using the system will input their data. The system will be ready for delivery only when all the errors and omissions are discovered and dealt with

This aims to inform the user where the data has been omitted for example forgetting to username when registering into the system.

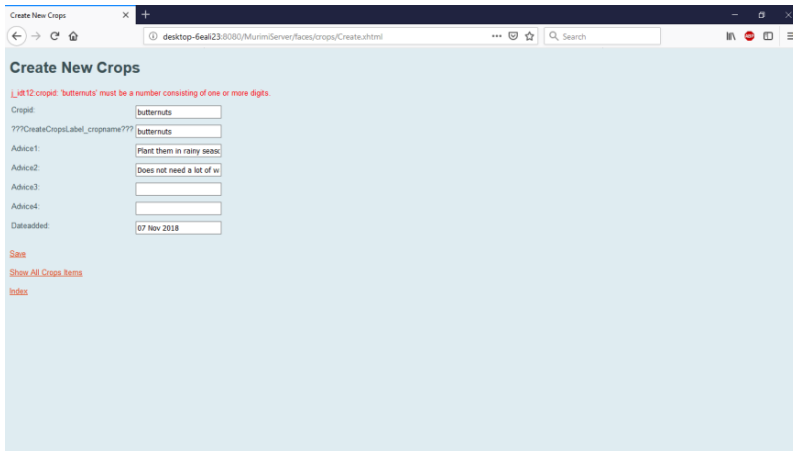


Fig 5.9 Wrong information entered

- Run the application and make sure unknown sources in phone security settings is not marked if marked unmark it as it may block the installation of the application.

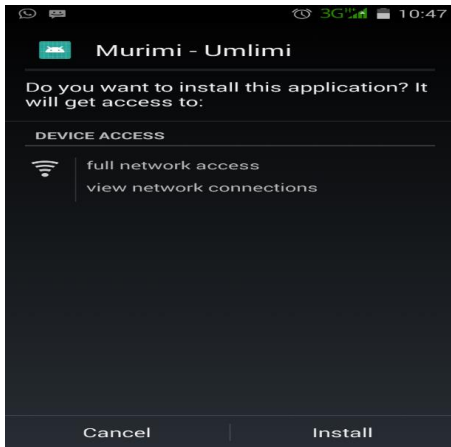


Fig.10 Running the setup

Click install to continue with the installation then if unknown devices are not selected go to settings

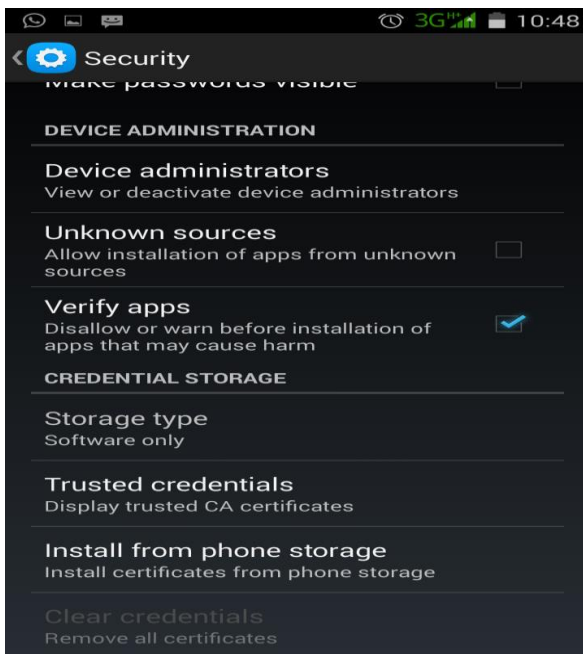


Fig 5.11 Security settings

Select on unknown sources and continue with the installation

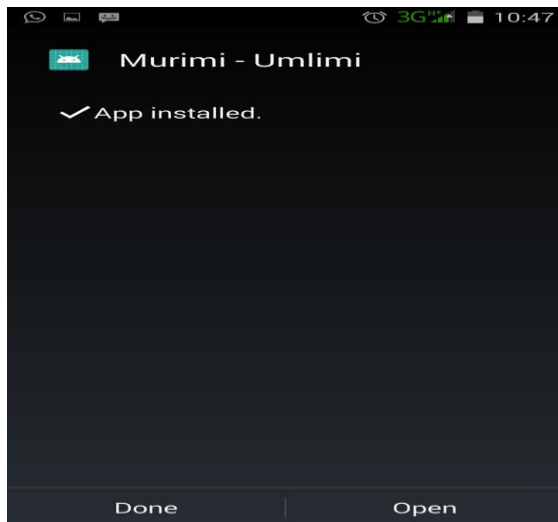


Fig 5.12 Installed application

1.146 5.4.1 User training

A training plan which included all the entities involved in the in the system was done Michael (2015). Management was also available such that all the users familiarize with the system so as to evaluate reports provided for evaluation purposes. Training was done so as to enable users to use the system. Training was not only for farmers but management, administrators, experts and extension officer needs to be trained so as to familiarize with the system. Trainees felt free to ask questions and have clarifications on what they wanted.

Training plan

The training was such that few experts and extension officers and few young and intelligent farmers to be selected and paid for the expenses by the ministry to go for the workshop which was held in the Capital on the 15th of October 2018 at Harare Agricultural Show. The developers had the projectors and showed the users on how they can access the system up to how they can make use of the system. Those who were available had the setup send to them and they would

send the same application to the farmers in their regions. The costs are summarized in the following table:

The hardware available met the system specifications and it was ready to be put to use. Software configurations where in place which included antiviruses to protect from virus threats. Operating system programs included windows 8 and 10. Network resources where available which included wireless and cables to use.

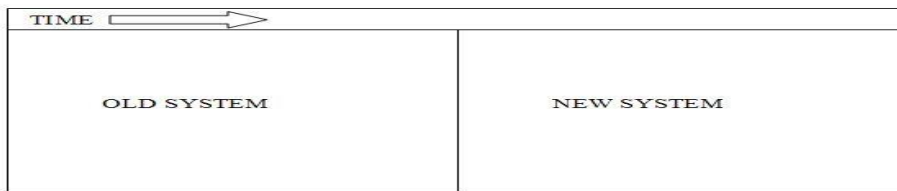

Data will be entered onto the system by the users as they will be using the system and this helps users to get used to the new system.

1.150 5.4.4 System conversion

Davis (2013) Is a technical process when the old is replaced by the new system. The farmers will have to make use of the application system after their training and the process is known as changeover. The changeover can be trivial to traumatic depending on the differences between the two systems. Pilot conversion is the changeover method used. The method is one in which the system is new to the organization altogether. Approaches used include:

5.4.4.1 Direct changeover

The new system immediately replaces the old system and the old no longer functions. It requires a lot of testing and training as it is too risky. It is a quick transition as there is not much to be done. It should be done when the organization is not under a lot of pressure as it may affect its



operations.

5.4.4.1 Advantages

Davis (2013) provides the following benefits and drawbacks of using direct changeover conversion:

- Efficient method as there is less duplication of work.
- Less costly as only one system would be in operation.

5.4.4.2 Disadvantages

- New system may meet the required objectives.
- During use some errors are identified which need corrections and this affects the system operation.
- Requires a lot of planning and testing.

1.152 5.4.5 Parallel running

The new and old systems run in parallel for a short period then the old ceases operation after sometime Marchekwa (2014) Gain certain benefits of keeping the old system installed and running if possible. It is possible only when the new and the old systems are

independent of each other and impossible when running both of them dependently as this will lead to the same data being captured. Using the conversion is less risky but more expensive as operation work will be doubled.

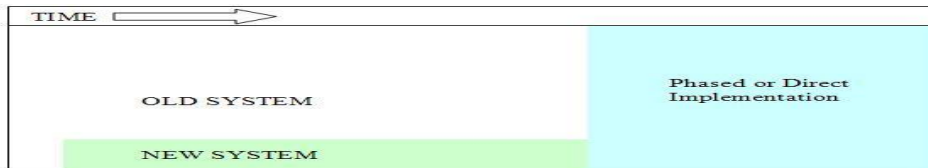


Fig.5.14 Parallel running diagram

- Cannot be used for different systems.

It is less costly and risky than parallel run approach. Errors are easily traced without affecting the business operations and b this builds confidence of using it. The organization may implement the new system in IT department and see how it performs and correct all errors before it is implemented to the whole organization and to the farmers

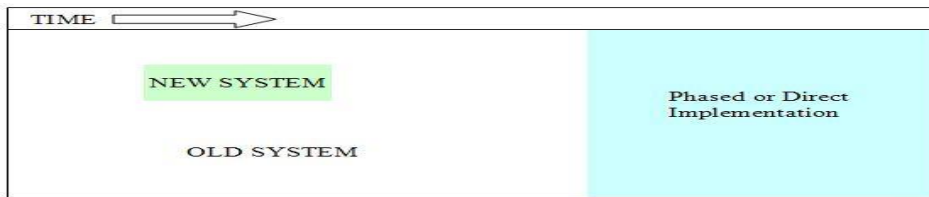


Fig 5.15 Pilot conversion diagram

5.4.6.1 Benefits

The system is implemented in stages or modules across the organization. Cost will be relatively moderate as the system is not implemented all at once. Several components will be introduced one after the other. This take more time but the users will be able to familiarise with the system. Problems with any step are dealt with before moving to the next step. It is impossible if the system is a one piece where it is all or nothing like the database systems

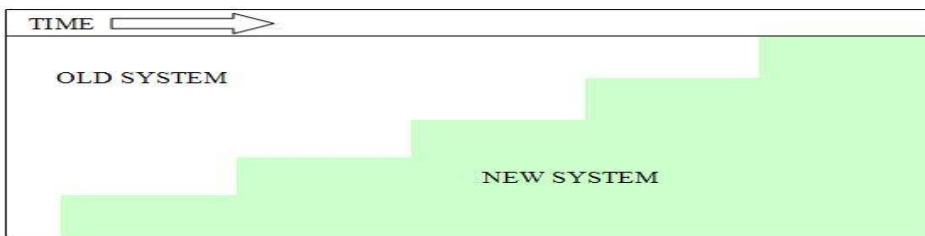


Fig 5.16 Phased changeover diagram

1.156 5.4.8 Post implementation

The proposed system proved to be very accurate and took a shorter time in producing outputs. There was higher farmer satisfaction. The system was easy to maintain and proved to be reliable. It had better security and control. After training the farmers could perfectly use the system and saw that it was much easy to use.

1.157 5.4.9 Conclusion on system conversion

Direct changeover was the best method of installing as the system is new to the organization and it lowers duplication of work and is less costly as one system will be operating.

Ahmed (2016) is a process done on a regular basis to ensure that the newly implemented system meets its addressed objectives. Periodic review, audit or monitoring is done so as to make sure the system is operating correctly and meeting organizational objectives. It is necessary for eliminating errors and change the system in response to the changes in technological environments.

Software maintenance include the following principles corrective, adaptive, and perfective Webb (2017). System review needs to be done. The types include:

- Corrective maintenance
- Perfective maintenance
- Adaptive maintenance

1.161 5.5.2 Corrective maintenance

This is for repairing software faults. Ahmed (2016) involves dealing with errors found and fixing them. The cropguard and pest control system will need coding errors as they arise after the users have become used to the system and coding errors is usually easy to correct, more design will be required to best suit user requirements which is costly. Cropguard and pest control system will require redesigning which is much more expensive because of requirements errors whereby the system should be able to operate on different operating system platforms like iPhone. Some anomalies may still exist even after all the intensive testing validation and verification done. All the corrections done are documented. It is an ongoing process as the users may notice the differences existing in the system. Management may find inadequate functions and lastly developers may notice differences not solved during development.

The software must be able to adopt changing operating environments Ahmed (2016). Done in response to the changes in the operating environment of the system. The system should be able to operate on iPhones and other devices and not only android devices. This is done when environment changes.
